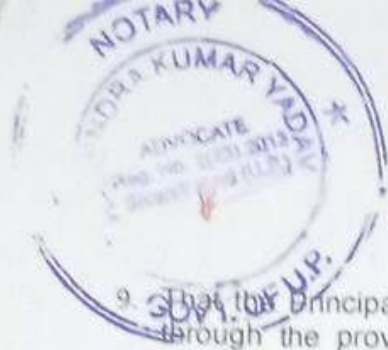
1. That Cambridge Institute of English Language Society is a registered Society/Trust under the Society Registration Act (Name of the Act under which society/trust is registered/ Section).
